COURSE DESCRIPTION
<p>International migration has become the concern of all in some form or another, with the questions of how to understand international migration in a globalized world, how to take advantage of it, how to live with it and how to manage it. With these questions in mind, it is important to keep pace with the growth of the phenomenon and understand the complexity of its linkages with other global issues primarily being security. With the help of the weekly lectures, upon completion of the course, students should be able to understand these linkages and relate migration issues to other global issues as well as contribute to the related discussion by academia, policy makers, and the general public.</p>
COURSE OBJECTIVES
<p>The course is a graduate-level survey of international migration and security studies. Upon the completion of the course, the students will learn about the main themes and concerns of international migration and will be able to trace the movements of various types of human population and groups across the globe. Through the coverage of the south-to-south and south-to-north migrations, economic dimension of people’s movement, refugee and asylum seeking movements due to various political issues, and etc., the students will have the opportunity to learn the elementary questions and problematique of international migration and security in a global world. This course will be a major contribution to the students’ academic background. The students will have the chance to learn more about international migration and inherent discussions on ‘push and pull factors of migration’, ‘transnational organized crime and human trafficking/smuggling’, international terrorism and migration routes and ‘demographic projections of population movements across regions’. Furthermore, they will obtain a detailed perspective on political and social life that will enrich their intellectual capacities.</p>
EVALUATION
<p>30% of the assessment will be based on in-class participation. This will take the form of participating in class discussions. Students will be expected to demonstrate evidence of having read and thought about that week’s topic and readings. 70% of the assessment will be based on midterm and final examination.</p>
