DERSİN TANIMI
<p>Bu ders, Rusya'nın küresel dünyadaki konumunu tanıtmayı ve Rusya'nın farklı dönemlerdeki uluslararası ve güvenlik politikalarının karmaşıklığının anlaşılmasını sağlamayı amaçlamaktadır. Ders, Rusya'nın uluslararası ilişkilerini, Rusya'nın dünya ile ilişkilerini şekillendiren düşünsel, yerel ve uluslararası faktörlere dayanarak inceler. Politika oluşturma sürecine ve Rusya'nın dış ve güvenlik politikasının belirli araç ve yöntemleri ile Rusya'nın dış politikasının ana yönlerine dikkat eder. Ders iki kısımdan oluşmaktadır. İlk kısımda, Rusya'nın uluslararası ilişkilerinin tarihsel bağlamı, Rusya'nın dış ve güvenlik politikasını oluşturma süreci, iç siyasi, düşünsel ve ekonomik faktörlerin rolüne atıfta bulunularak analiz edilecektir. İkinci kısım, SSCB'nin çöküşünden başlayarak Rus dış politikasının başlıca itici güçlerine ve aşamalarına genel bir bakış olarak tasarlanmıştır. Öğrenciler, AB, eski Sovyet coğrafyası, ABD ve NATO, Orta Doğu, Çin, Asya, Latin Amerika ve Afrika gibi ülkeler, bölgeler ve örgütlerle ilgili olarak Rusya'nın küresel çok kutuplu dünyada kendini tanımlayışı ve konumlandırışını öğreneceklerdir. Ders, Rusya'nın küresel yönetişime yaklaşımı ve küresel yönetişimdeki rolünün değerlendirilmesiyle son bulacaktır.</p>
DERSİN AMACI
<p>Bu dersin sonunda öğrenciler, Rus dış ve güvenlik politikasının sürekliliği ve değişiminin tarihsel süreci hakkında bilgi sahibi olacaklardır. Buna ek olarak, bu ders öğrencilere Rusya'nın AB, eski Sovyet coğrafyası, ABD ve NATO, Orta Doğu, Çin, Asya, Latin Amerika ve Afrika'ya yönelik dış politikasının ana yönlerini analiz edebilecek bilgiyi sağlamayı amaçlamaktadır. Dersin sonunda öğrenciler, Rusya'nın uluslararası sistemdeki mevcut konumu ve bu konumun tarihsel kökenleri hakkında güçlü bir anlayışa sahip olacaklardır. Özellikle, öğrenciler Rus dış ve güvenlik politikasının itici güçleri ve aşamaları ile Rusya'nın küresel çok kutuplu dünyada kendini konumlandırması hakkında bilgi sahibi olacaklardır.</p>

COURSE DESCRIPTION
<p>The course is intended to introduce the Russian self-positioning in the global world and to provide understanding of the complexities of Russia's international and security policies in different periods. It examines Russia's international relations with special reference to ideational, domestic and international factors that shape Russia's engagement with the world. It pays attention to the policy-making process and to specific tools and methods of Russia's foreign and security policy, as well as to major directions of Russia's foreign policy. The course consists of two parts. The first will analyze the historical context of Russia's international relations, the process of formulating Russia's foreign and security policy, with special reference to the role of domestic political, ideational and economic factors. The second part is designed as an overview of major driving forces and stages of the Russian foreign policy starting from the collapse of the USSR. The students will learn of Russia's self-perception and self-positioning in the global multipolar world, with respect to such countries, regions and organizations as: the EU, the post-Soviet region, the US and NATO, the Middle East, China, Asia, Latin America and Africa. The course will conclude with an assessment of Russia's approach to and role in global governance.</p>
COURSE OBJECTIVES
<p>At the end of this course, students will have knowledge about the historical process of continuity and change of Russian foreign and security policy. In addition, this course aims to provide students with the knowledge to analyze major directions of Russia's foreign policy towards the EU, the post-Soviet region, the US and NATO, the Middle East, China, Asia, Latin America and Africa. By the end of the course, students would have a strong understanding of Russia's current position in the international system and the historical origins of this position. Specifically, students will have insights into driving forces and stages of the Russian foreign and security policy, and Russia's self-positioning in the global multipolar world.</p>
